If you are petitioning a non-departmental course for concentration credit, be sure to explain how the course meets the criteria for petitioned course described on the Approved Non-Departmental Courses page.

**Regarding cross-registered courses:** there is a form required by the FAS Registrar if you are cross-registering into a course at a different school (e.g., HGSE, HKS) and want concentration credit. If this is the case, please bring the Registrar form with you when you submit this petition to the UGO, as you will need the UGO's signature on it.

When you have completed the form and compiled the attachments, you must obtain a **signature from your Concentration Advisor** in order for the Department to consider your petition. These signatures attest that you have discussed your petition with your Concentration Advisor, and that your Advisor believes you have made the strongest possible case for your request. This signature does not signify that your Advisor agrees with your request or that the Department approves it.

Please submit your completed petition to the Undergraduate Office (in William James Hall 218 or to psychology@wjh.harvard.edu) by the designated deadline.

Following this, the Director of Undergraduate Studies & Associate Director of Undergraduate Studies will review your petition and e-mail you when they have reached a decision. Feel free to contact the Undergraduate Office to check on the status of your petition!
