## **APPLICANT INFORMATION:**

Please fill out the form completely. Please mark whether you plan to take the course for letter grade or pass/fail, and note that 910R cannot count for the Psychology concentration or secondary field if it is taken pass/fail.

Please enter how many times you have taken 910R, and how many other lab methods courses you have taken (full list available on the [Undergraduate Office website](#)). Please note there are limits on the number of research courses you may count toward Psychology concentration or secondary field requirements.

## **SUPERVISOR INFORMATION:**

*Supervisor:* Your supervisor must be an assistant, associate, or full professor in the department, or an asterisked member of the [Board of Honors Tutors](#). You must provide their e-mail address. Your supervisor must sign and date the form itself; e-mailed approvals will not be accepted.

*Co-Supervisor:* Not required, but in some instances, you may be working directly with a departmental graduate student or post-doctoral researcher, or with a non-departmental researcher (Research Assistants may not serve as co-supervisors). This is permitted only if you have a department faculty supervisor. Graduate students may serve as co-supervisors only if they are students in the Department of Psychology, are making good progress on or have completed their second-year project, and have the permission of their advisors. Attach a CV for any non-departmental researcher supervisor who is not on the Board of Honors Tutors. You must provide the e-mail, job title, and institution of your co-supervisor on your application so that the UGO will be able to contact them if necessary. Your co-supervisor must sign and date the form itself; e-mailed approvals will not be accepted.

## **RELEVANT RESEARCH ARTICLE:**

Provide a complete citation (title, author, date of publication, journal, etc) for either a) a review article about the area of research you are undertaking or b) 3 research articles that are related to the research you will be doing. Your application will not be approved without this information. You may consult with your supervisor or co-supervisor for help identifying relevant articles.

## **PROJECT DESCRIPTION:**

Provide a short paragraph explaining your project. This description should describe your exact role on the project, rather than being just a general summary of research going on in a lab. For instance, submitting a portion of a supervisor's grant proposal would not be acceptable. Be as specific as possible in your description, although we do appreciate that a project may change significantly over the course of the semester.

## **SIGNATURE:**

You must read and acknowledge the requirements of Psychology 910R at the bottom of the page. PSY 910R is administered by the Psychology Undergraduate Office and has standardized requirements, so please check with the UGO if you have any questions about deadlines or procedures throughout the semester.

## **SUBMISSION:**

You must submit the application to the Psychology Undergraduate Office - either in-person at William James Hall 218, or via e-mail at [psychology@wjh.harvard.edu](mailto:psychology@wjh.harvard.edu) - by **4 PM the weekday before the Course Registration Deadline**.
