

Instructions for PSY 985 Enrollment Form

Application Instructions:

Enrollee: Please *legibly* fill out the information at the top of the form

Supervisor: Only current departmental faculty member (assistant, associate, or full professors), asterisked member of the [Board of Honors Tutors](#), and (pending departmental approval) departmental lecturers and college fellows are eligible to serve as supervisor.

Co-Supervisor: In some instances, you may be working directly with a departmental graduate student or with a non-departmental researcher. This is permitted if you have a department faculty supervisor. If this person is not a departmental researcher or a member of the [Board of Honors Tutors](#), departmental approval is required.

Be certain to include CVs for any Co-supervisor who is not a departmental graduate student, FAS faculty member, or Board of Honors Tutor member.

PSY 1901: Please indicate when you took PSY 1901 (or are planning to take it) and the grade you received.

College GPA: The thesis program requires a College GPA of 3.5 or higher at the time you submit your thesis application. A petition process is in place for people with GPAs below this cutoff and students are advised to consult the department as early as possible if they plan to petition.

Project Description: Provide a short paragraph explaining your project. Be as specific as possible, although we do understand that a project may change significantly over the course of the semester.

Concentration Advisor signature: Have your CA sign the form at your beginning of term advising session, which should cover thesis planning.

Submission and Crimson Carts for the Course

You must submit this application in hard copy to the Psychology Undergraduate Office, WJH 218. The application needs to be reviewed by the UGO staff, and once the application is approved, they will sign your Crimson Cart. *Please note your faculty supervisors DO NOT sign your study card for this course!*
