

## Research Assistant at Temple University

Under the supervision of Dr. Ellman and a postdoctoral employee, the research assistant will aid in collecting and managing data in a multi-site study aiming to identify biomarkers and associated predictors of clinical and behavioral outcomes in at-risk populations. The research assistant will be involved in data collection at all time points and will administer semi-structured clinical interviews and cognitive tasks, as well as the collection of bio samples, including EEG data, MRI data, and processing blood samples (which will be collected by a phlebotomist). The research assistant will also assist lab staff with daily lab operations such recruiting participants, managing data, and supervising undergraduate volunteers. The ideal candidate will have prior experience working in a psychological research lab. Performs other duties as assigned.
